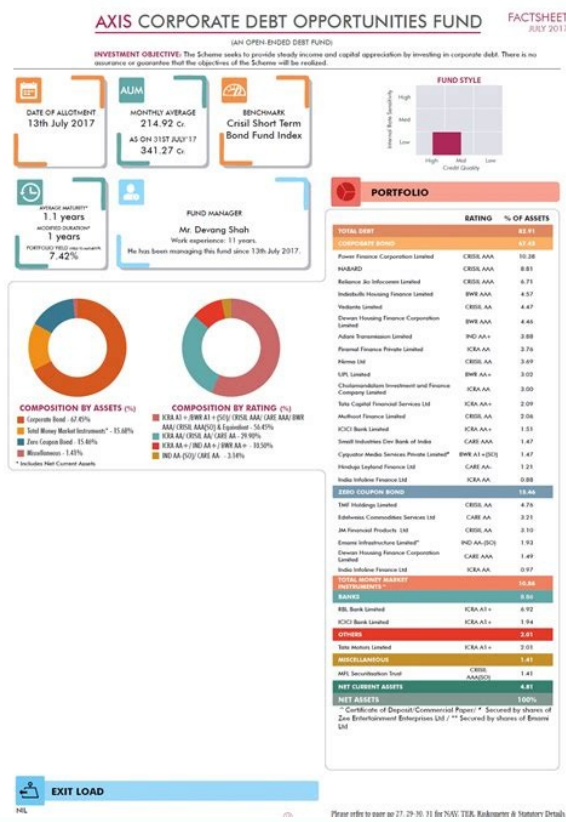

In some instances, you may have to pay a sales charge when you redeem your shares, while in other instances no charges are assessed. Open-ended mutual funds are priced daily after the close of the New York Stock Exchange. No-load funds often assess transaction fees that you pay when you buy or redeem shares. You can sell your shares on the open market, since shares in closed-end funds trade similarly to stocks. In the redemption form one needs to fill in details like unit holder's name, folio number, scheme name including the plan details, and number of units to redeemed (or the redemption amount desired). Please note that these agencies might not service all the AMCs. On A class shares, you pay the sales charge at the time of purchase. Unlike sales charges, redemption fees are normally fixed-fee costs rather than charges based on the value of the shares you redeem. The sales charge is always assessed as a percentage of the value of your redeemed shares rather than as flat dollar fee. It is generally not possible to redeem shares in a closed fund, although fund companies sometimes allow to redeem shares at fixed intervals during the investment term. In C shares you usually pay the redemption fee only for the shares you have owned for less than a year. The refund proceeds will be credited to the registered bank account of the first owner of the unit. Shares of open-ended investment funds may not be sold on the secondary market. In order to redeem funds via offline mode, the unit holder must submit a duly signed redemption request form to the office designated by the AMC or the Registrar. Repayment rules differ between so-called fixed-capital funds and those designated as fixed-capital funds. Class B and C shares do not cost anything upfront, but have a deferred contingent sale charge or a back-end charge. If no broker is involved, the fund company keeps the money obtained from the selling expenses.
